- (2) The beneficial owners of 232,500 shares of Series A Common Stock exchanged such shares for 232,500 shares of Common Stock. The transaction involved a direct exchange of the shares with AMERCO.
- (3) Mr. Shoen indirectly beneficially owns (i) 1,946,314 shares of Common Stock through JPS Partners, Ltd., and (ii) 3,915 shares of Common Stock through the ESOP Trust Fund for the AMERCO Employee Savings and Employee Stock Ownership Trust. Mr. Shoen controls JPS Partners, Ltd. for purposes of Rule 16a-1(a)(1) and is therefore deemed to indirectly beneficially own such shares of Common Stock held by JPS Parters, Ltd.
